

documentation to the full Board for action. Such a recommendation, once made, will lay on the table at least 21 days before final adoption to allow for public comment.

B. Consideration will be given for requests to honor distinguished persons who shall have made an outstanding contribution to a school, the Guilford County Schools, the community, the county, the state, or the nation, and who are either deceased, or retired from active participation in the school, community, county, state, or national affairs for which they are being recognized.

C. Project teams, school and community groups, or individuals should insure that persons they consider for the honor of having a facility named for them must meet the following criteria:

- Must have obtained a record of recognizable excellence in their respective field evidenced by a variety of outstanding accomplishments, awards and leadership and service roles in their profession, community, professional and civic organizations.
- Must have been a positive role model for others.
- Must have exhibited values like honesty, integrity, respect, sense of fairness, concern for others, self-discipline, teamwork, dedication to work, etc.
- Must have shown a commitment to excellence.

D. Broad support for these requests must be shown at the school and/or in the community. This support should be evidenced from parents, faculty, school organizations, current and former students and friends of the school, community organizations, and community.

E. If the Board selects a person or family as the name of a school or school building, it will be responsible for providing appropriate recognition, such as a plaque, portrait, marker, etc., for the school or facility.

IV. All Nominations for naming or renaming school facilities must be made by submitting a completed Naming of Schools and School Facilities Nomination Form to the Superintendent or his/her designee.
