Events and conferences will also be offered virtually to allow families the opportunity to participate on-line.
- Involve parents in the development of PFE plan and the Title I program: Parents on the School Improvement
 Team will have the opportunity to provide input. All other families will have the opportunity to view the draft
 that will be posted on our website and provide feedback.
- Provide information to parents: Important information will be shared via weekly Monday folders, school newsletters, ClassDojo, Sunday phone calls from the Principal and school social media sites. We encourage all families to stay connected.
- Allow for comments on plans: During Spring 2022, families will have the opportunity to view the draft that
 will be posted on our website and provide feedback on the draft. Feedback will then be considered, and the
 plan updated to the greatest extent possible.
