The Transportation Institute at North Carolina A&T State University is now accepting applications for the 27th Summer High School Transportation Institute (STI).

The non-residential STI introduces high school students to the many career opportunities available in the transportation industry. The program features 5½ weeks of field trips, classroom lectures, hands-on projects, and networking opportunities with industry professionals. The curriculum also features SAT prep and activities that promote self-awareness and personal development.

To apply, students should be entering the 11th or 12th grade for the 2019-2020 school year and have a minimum GPA of 2.5 on a 4.0 scale.

Students must submit the following:

- Completed application form
- Official high school academic transcript
- Typed 250 word essay describing your interest in attending the STI and how the STI might assist you in achieving your educational and career goals
- Two letters of recommendation, one from a school guidance counselor and one from a teacher who is familiar with the applicant's character, abilities and accomplishments
