## Orientation Sessions - August 17 – September 4

- Each school will contact parents to set up a time for an orientation session.
- Orientation sessions will include:
  - Universal Pre-Assessment
  - Navigating Canvas
  - Understanding Google Apps for Education
  - Accessing digital textbooks
  - Participating in live instruction
  - Submitting assignments
  - Accessing recorded lessons
  - Understanding your child’s remote learning day

## Instructional Expectations (Weeks 4-9)

### Daily Expectations for Remote Instruction

Grade Level	Synchronous (Live) Instruction	Asynchronous (Recorded) Instruction and Other Digital Resources
PreK – 1 <sup>st</sup> Grade	1 hour	2 hours
2 <sup>nd</sup> – 5 <sup>th</sup> Grade	3 hours	Up to 2 hours

- Teachers deliver live synchronous lessons four days a week with small group and individual check-ins/assessments and district-provided content on Fridays
  - Lessons should be recorded and posted so students who cannot log on, can access later
  - Recorded lessons can also be used in addition to live instruction
- Grades will be assigned following the district grading policy as approved by the Board of Education ([Click here for the policy](#))

- Work assigned to students will be grade level content
- Students will continue to receive specials classes and electives such as art, global languages and Physical Education

# What Parents Need to Know About the First Nine Weeks



- **Elementary students** will have an opportunity to:
  - Receive live, virtual instruction from their teacher (4) days a week, with individual and small group check-ins on Fridays.
  - Join their classmates for class meetings and social-emotional learning.
  - Engage in small groups for instruction as needed.
  - Work independently on assignments and projects.
  - Take movement breaks and screen breaks throughout the day.
  - Participate in special area class instruction in art, music, library, and physical education.

## Attendance and Grading

- Attendance will be taken daily. If your child will not be participating in class, please contact the school.
- Students that do not log in will be contacted by the school each day.
- Schools must attempt to make contact with parents before marking students absent.
- Grades will be assigned following the district grading policy as approved by the Board of Education. ([Click here for the policy](#))

## AIG Services, English Learners, Students with Disabilities, 504 plans

- Students that would typically receive any services, should continue to receive these same services. Schedules should be developed around service times so that students are able to participate in classroom instruction and receive services.
- Teachers should maintain ongoing communication with students in the form of email, phone check-ins, newsletters and other means of communication weekly.
- Services delivered should be logged weekly.
- The opportunity for students to make appointments for related services that cannot be provided remotely should be available at all school locations.
