August 5 – September 18	WIDA Remote Screening	WIDA Remote Screening <i>During Remote Learning with no students in school, English Language teachers will use this pathway when screening students to determine if they qualify for English Language services until the students can be administered the state approved W-APT/WIDA Screener after returning to in-person instruction. The Family/Caregiver Interview is recognized by NCDPI ESL/Title III and Accountability.</i>
September 17 – 30 February 16 – 26	CDM	Credit by Demonstrated Mastery <i>A process by which Guilford County Schools, based upon a body-of-evidence, awards a student credit in a course without requiring the student to complete classroom instruction for a certain amount of seat time.</i>
October 20 – December 3	WIDA™	WIDA <i>This is the state instrument for identification of English Learner (EL) students. In Guilford County Schools, this test is coordinated by the district's English as a Second Language (ESL) Department.</i>
October 27 – December 11	PreACT®	Preliminary ACT <i>This test simulates the ACT® testing experience on all four subjects of The ACT® Test: English, math, reading, and science. The results on this test predict future success on the ACT®. In North Carolina, students enrolled in the tenth grade, who are following a course of study that, upon graduation, will lead to admission into a college-level course of study resulting in a college degree, take the PreACT™.</i>
October 27 – December 11	CCRAA at 10	College and Career Readiness Alternate Assessment at Grade 10 <i>Available to students who have an Individual Education Program (IEP) that are following a course of study that, upon graduation, may not lead to admission into a college-level course of study resulting in a college degree. In North Carolina, the CCRAA at Grade 10 is the state-developed, alternate assessment for the PreACT™.</i>
November 16 – December 11 and April 12 – 23	WorkKeys	The ACT WorkKeys™ <i>This test is a standardized skills assessment designed to measure career readiness. In North Carolina, seniors who are identified as Career Technical Education (CTE) concentrators take The ACT® WorkKeys.</i>
December 14 – 18 and May 18 – 24	EOC Block	End-of-Course <i>All students enrolled in Biology, English II, and/or NC Math I are expected to participate in the appropriate End-of-Course assessment.</i>
January 25 – March 5	ACCESS	ACCESS for ELLs 2.0® <i>During the annual English language proficiency testing window, all students identified as English Learner (EL) students, must be administered this test, or the Alternate ACCESS for ELLs®. In Guilford County Schools, this test is coordinated by the district's English as a Second Language (ESL) Department.</i>
February 23 and March 9 (Makeup)	ACT®	The ACT® Test <i>A standardized test, for high school students, administered by ACT designed to measure college readiness. In North Carolina, students enrolled in the eleventh grade, who are following a course of study that, upon graduation, will lead to admission into a college-level course of study resulting in a college degree, take The ACT® Test.</i>
February 23 – March 5 and March 9 – 19 (Makeups)	CCRAA at 11	College and Career Readiness Alternate Assessment at Grade 11 <i>Available to students who have an Individual Education Program (IEP) that are following a course of study that, upon graduation, may not lead to admission into a college-level course of study resulting in a college degree. In North Carolina, the CCRAA at Grade 11 is the state-developed, alternate assessment for The ACT®. Students approved for ACT® accommodations test during the ACT® Accommodations window.</i>
March 9	ACT Makeup from Spring 2020	The ACT® Makeup Test <i>In March 2020, the makeup test for students absent from the February 2020 administration of the ACT was cancelled due to school closure from COVID-19. Students who were scheduled to participate in the March 2020 makeup session will participate in this administration of the ACT.</i>
