b. Review 2017-2018 EVAAS Growth Data

- i. 2016—5.89 Exceeded
- ii. 2017-- -4.38 Not Met

c. Establish 2018-19 Goals

- i. By June 2019, NGMS will reduce the achievement gap between the performance of white and black students in reading and math by 20% as measured by the EOG Reading and Math assessments. This would reduce the current gap in reading from 27.9% points to 22.32% points and in math from 34.3% points to 27.4% points.
- ii. By June 2019, NGMS will decrease the number of referrals by 15% reducing referrals from 352 to 299.
- iii. By June 2019, NGMS will increase the school EOG Science proficiency 5% points from 81.1% to 86.1%.

- iv. By June 2019, NGMS will increase the school EOG Reading proficiency 3% points from 69.4% to 72.4%.
 - v. By June 2019, NGMS will increase the school EOG Math proficiency 3% points from 66.3% to 69.3%.
 - d. Car Rider Line Protocols
 - i. Morning Car Rider all being dropped off by 8:40
 - ii. Afternoon Line
